LIABILITY WAIVER-this affects your legal rights, READ IT CAREFULLY:

You, the undersigned, being 18 years of age or older, (on behalf of the student named above if under 18) are aware that there are risks associated with participating in Fitness and Dance classes. Your participation is completely voluntary, and you fully accept and assume all responsibility for all risks, possibilities of personal injury, death, property damage or loss to yourself or any other person as a result of your participation in fitness and dance activities. You and your heirs, next of kin, executors, administrators and assigns agree:

- a) To waive all claims, known or unknown, that you have or may have in the future against Regina Salseros Dance Class and instructors, including their owners, officers, directors, agents, employees, volunteers, business operators, independent contractors and site property owners of lessees;
- b) That Regina Salseros Dance Class and the class instructor are not liable or responsible for any damage to, loss, or theft of your property.
- c) To release and forever discharge Regina Salseros Dance Class and the class instructor from all liability for any person injury, death, property damage or loss resulting from your participation in fitness and dance activities due to any cause, including but not limited to negligence, breach of any duty imposed by law, breach of contract or mistake in error of judgement of Regina Salseros Dance Class and the class instructor; and
- d) To be liable and to hold harmless and indemnify Regina Salseros Dance Class and the class instructor from all actions, proceedings, claims, damages, costs demands, including court costs on a solicitor and own client basis, and liabilities of whatsoever nature or kind arising out of or in any way connected with you participation in fitness and dance activities.

PAYMENT TERMS & CONDITIONS:

- A minimum of 10 students are required to run a course. Students who have registered for a session that has been cancelled will receive credit towards a future session.
- Due to limited scheduling, we cannot offer "make up" classes if you miss one when purchasing a course.
- Cancellation must be received in writing 24 hours prior to the start of the class/event to receive a full refund. If you need to cancel once the course has started, Regina Salseros Dance Class or the class instructor will charge you \$20 for each class scheduled prior to discontinuation and will credit the remainder for a future course.
- Gift Certificates are valid for the period in which you have registered. When registering for a class you must present your gift certificate on the first day of classes in order to validate it. If you are unable to continue the course, you must notify Regina Salseros within 48 hours so that a new gift certificate may be issued. After 48 hrs from the first class your certificate is automatically fulfilled and Regina Salseros will no longer issue a new one.

NEW SAFETY MEASURES & CLASS INFORMATION

please read carefully before registering:

1. **CLASS SIZE & DISTANCING** Class size is limited to 8 students total, classes will fill faster than normal, and it is first come first served. Individual dance areas will be set out so that students keep their distance from each other and from instructors. Students are supposed to come in one by one and go to designated spot on the dance floor.
2. **STUDENT HEALTH** Before each class each student must attest to have not traveled in previous 2 weeks, not have any COVID-19 symptoms, and not to have come into contact with anyone with symptoms
3. **COVID EXPOSURE** In the event that a student has tested positive for COVID-19, all students will be notified, and proper measures shall be taken.
4. **STUDIO CLEANING** The studio will be fully cleaned at the end of classes.
5. **STUDENT HYGIENE** Students will be required to use the hand sanitizer provided before and after class. Students are also required to wear a mask during class. We ask that you the parents also wear a mask whenever at the studio.
6. **PERSONAL BELONGINGS** We ask students to not bring anything other than their dance shoes. One small bag with their belongings would be fine and use the hooks provided (hooks are sanitized before each class)
7. **LEAVE AFTER CLASS** Please do not linger or visit after classes, we require students to leave immediately to ensure we can properly clean and disinfect before the next class. Each student is to leave one by one.
8. **WASHROOMS:**
Use of washrooms will be minimal, so if you can refrain from using the washrooms that will be the preference.
9. **KIDS ALLERGIES:**
Please let us know if your child has any food allergies. Snacks may be provided during classes.

PLEASE NOTE: In the event that the government regulations require Regina Salseros to stop studio operations, classes will be moved online via Zoom. There will be no refunds or credits given if a student chooses to withdrawal from class.
